3. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall have been registered in the field and grade mentioned in the table below with the **Construction Industry Development Authority (CIDA)**.

Late Bids will be rejected. Bids will be opened soon after closing in the presence of the Bidder's representatives who choose to attend.
